New Business

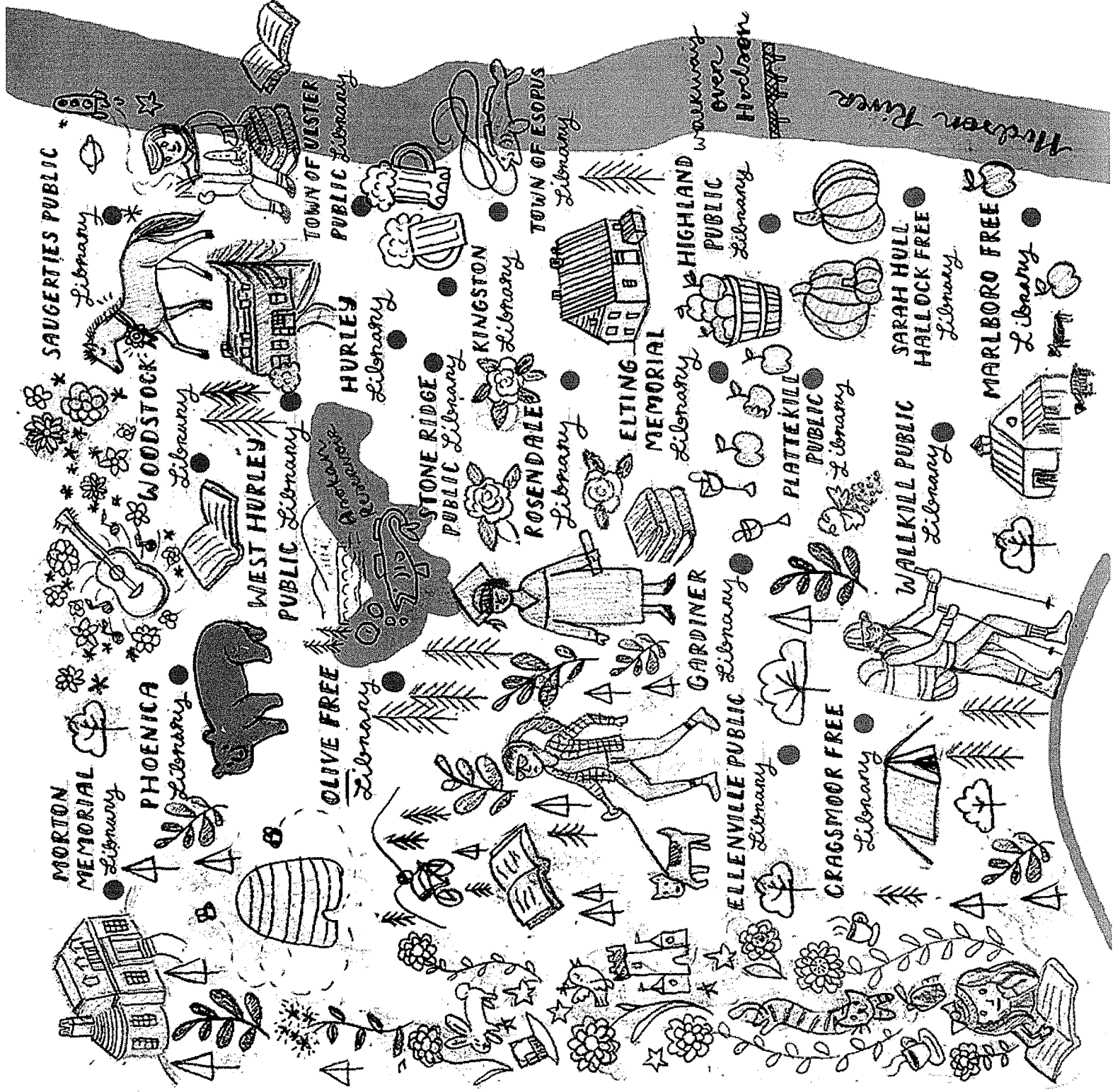
Treasurer: Margie Menard made a motion to appoint Brooke Dittmar as treasurer for the remainder of Frank Rees' term, 2nd. Approved.
