James Cosgrove reported that contracts have been signed with Universal Classroom and Tutor.com. Kara Lustiber is working on the technical end to make sure we are ready to go. Training on Tutor.com will be offered at the Kingston Library on Friday, April 20<sup>th</sup> at 10am. All library staff are encouraged to attend, but please let Margie know how many plan to attend. Kelly Tomaseski will send out an email to member libraries alerting them to the training session. Ken Goldberg asked if there is an evaluation system to determine which of the online products are most popular.

Jim reported that some county funds will be used to purchase e-book titles on Overdrive. Amy Raff is looking to see if there are two log-in levels—one to view and make suggestions, one to actually purchase.

The association is looking at providing training for the Infoportal products. Faith Johnson and Heather Olson are researching a WOMM plan. Thursday, May 17<sup>th</sup> MHLS is offering a workshop on OPAC/Novel Databases. Jim suggested a possible piggyback where ULCA will offer an additional hour of training on specific Infoportal tools. UCLA would provide lunch for those in attendance. Julie Johnson recommended circulating the scavenger hunt created by Merribeth Advocate as part of the Building your Base Online course. The Town of Ulster will also be creating youtube tutorial videos of patrons using the online tools. The piggyback idea was tabled.

**Advocacy:** Jim reported that Casandra Beam of the Ulster Literacy Association would like individual libraries to contact her about which materials they should purchase for their collections. It was agreed that all of these items should be catalogued with the same I-code. Kingston has already added these items, so Margie will let everyone know what I-code they used.

We need volunteers to attend the Legislative Programs, Education and Community Services Committee meetings (July 3, July 31, Sept 4, Oct 2, Oct 30, Nov 27 at UCCC). Jim and Margie have been attending, but we need new faces. The committee seems to appreciate short presentations. Adele Reiter, Deputy County Executive, Chief of Staff is a good contact person for the Ulster County Legislator.

Thank you to Mary Lou Carolan for organizing the Hudson Valley Renegades fundraiser. For \$15 patrons will get admission to the June 30<sup>th</sup> game, along with a free hat and admission to after game fireworks. If the minimum number of tickets is sold, \$3 of each ticket purchased will go toward the UCLA.
