# Operational/Management Functions of OverDrive Marketplace

revised June 2017

The MHLS OverDrive eBook and eAudiobook service was established in 2010 and has proved highly successful as measured by patron demand. Each year circulation has increased (235,839 circulations in 2016, a 21% increase over the previous year).

## **HOW ARE MY PATRONS USING OVERDRIVE?**

- The following OverDrive statistics are posted monthly by MHLS at midhudson.org (in the Topics section) showing current usage by your patrons as well as annual totals of your library for trend comparison:
  - o The number of eBook titles and eAudio titles your patrons checked out
  - The number of new users that registered from your library
  - o The number of unique users with checkouts from your library
- Through OverDrive Marketplace Reports at <a href="https://marketplace.overdrive.com">https://marketplace.overdrive.com</a> you can run reports with more detail for your library including:
  - Titles that patrons from your library are currently on the waiting list for, so you know what your patrons are interested in
  - Holds ratio for consortium owned copies, so you know how long your patrons will be waiting for their holds from the consortium collection
  - Metered titles on hold by your patrons that have no circulations left these are titles that need to be repurchased for your patron to get their hold filled
  - Usage of materials by your patrons by subject, audience level (adult, juvenile, YA), language
- Know what titles your patron have on hold (high demand holds)



- In OverDrive Marketplace you can create a Holds Manager plan that will build a cart for you based on your patrons high demand holds (following parameters you set), that you can review and edit.
- Your patrons are asking for new titles they would like your library to purchase.



 A reminder that as per the DA, the built-in OverDrive 'Recommend to Library' was been enabled so that individual libraries would be able to get

- recommendations from their patrons of OverDrive titles that would like the library to purchase.
- In OverDrive Marketplace you can run the Recommendations report to review your users' recommendations, and easily convert them to a cart that you can review and edit.

#### **PURCHASING**

- The invoice comes directly to the library from OverDrive. Titles (or copies) purchased are available for checkout within 24 hours.
- Marketplace Help at <a href="https://help.marketplace.overdrive.com/">https://help.marketplace.overdrive.com/</a> provides step-by-step directions for purchasing, as well as how to purchase content credit to spend on future purchases.
- Traditional individual accounts
  - Items/copies purchased through traditional individual accounts go into the consortium collection, and can be borrowed by all member library patrons, in the order that their holds are placed.
- Advantage accounts
  - OverDrive content though an Advantage account. OverDrive Advantage accounts are available to every member library. About 1/3 of member libraries have set up Advantage accounts at this point. Advantage library patrons have access to titles in the shared collection, plus they have priority access to additional titles or copies purchased through their library's (as determined by home library code in the patron record) Advantage account. This is a way to reduce your users' wait time for popular titles.
    - If you already have an Advantage account, note that the DA approved settings were applied at the consortium level, every Advantage account is automatically opted in, and no additional action is needed by you to enable this feature.
    - If you do not yet have an Advantage account, email our OverDrive Collection Development Specialist Kristin Preyss (<a href="mailto:kpreyss@overdrive.com">kpreyss@overdrive.com</a> for the enrollment form. At this point OverDrive is continuing to offer enrollment for the price of 3 curated titles.
  - Libraries wishing to purchase Advantage content sign in to Marketplace through their Advantage account for purchasing.

  for 1st time users.
- Designed for ease of use, Libby eliminates the need for format selection (uses
   OverDrive Read and OverDrive Listen) and contains new features that make the
   digital library fresh and fun. Libby can be used in place of, or in addition to, the
   OverDrive app.
