The meeting of the Ulster County Library Association was called to order by Margie Menard at 10:00am at the Stone Ridge Library.

**Recorded Books Presentation:** Representatives described the RBdigital App & Platform. The model is a pay-as-you-go model with the libraries paying \$2.00 for an account to stream for a week from each of the channels on the platform. Comics and magazines are ordered individually. Movies include public streaming rights if the library is sponsoring the program.

**Minutes**: Margie Menard made a motion to approve the February meeting minutes, 2<sup>nd</sup>. Approved.

**MHLS Sierra auto-renewal**: (Document attached) Users whose materials are auto renewed are notified via email only. The group recommended the notification go out two days before the renewal at 5am.

#### PR Committee:

- Universal Class: Katie Scott-Childress will field any recommended changes to the Press Release for Universal Class. (Draft is attached). The PR firm will create a brochure for each library. Libraries are reminded to make sure that they have a button on their website with the text *Take* an Online Class.

#### **MHLS System Services:**

There is a gap between the budget amount for truck delivery and the lowest bidder. System services reevaluated budget and recommended that member assessments be increased about 1 to 2%. This is the first increase in eight years. The assessment will be discussed at the March DA Meeting and voted on at the April DA Meeting.

#### **MHLS Central Library Committee:**

Central Library has \$52,000 in excess funds which could be spent on delivery. The system services committee has recommended that it be spent for delivery. After discussion, the UCLA agreed that their representatives should support this recommendation at the Central Library Committee.

#### **Fine Free Libraries:**

Laurie Shedrick will run reports on the number of patrons blocked by owed fines and the amount of money owed on children's materials. Consensus was for libraries to consider a county wide initiative to remove fines for children up to age 15 with the privilege being attached to the child's library card. #### New Feature F.A.Q.

#### AUTO RENEWAL / COURTESY NOTICES

#### What is Auto Renewal?

Auto Renewal is a feature which renews eligible items that are checked out to patrons in good standing, in an automated process, using Courtesy Notices. Three days before the item is due, the patron will receive an email notice to inform them that their item has been renewed, and will now be due at a later date. The new renewal date is based on the original checkout date. This feature has been received very positively by patrons and librarians alike in neighboring communities. It is considered a customer service improvement.

Example: a book that checks out for 21 days and is due on April 1, 2019 will be renewed to be due on April 22 (21 days after the original due date) if the following is true.

- The patron is not expired
- The patron owes less than \$10
- The item has not met the renewal limit of holds (some limits are set to 0, some are as high as 2)
- The item or title does not have more holds than available copies.

#### What if the item has holds?

The item <u>must be eliqible for renewal</u>. The same loaning rules that would apply to a manual renewal would still apply. The patron's card cannot be expired or blocked, the item must have less holds than available copies and the number of renewals allowed by the lending library cannot be met or exceeded. If an item cannot be renewed, the notice will inform that it could not and the original due date will be shown.

My library has things that don't renew-Museum passes and equipment. Will they renewed?

No. If an item doesn't renew now, it is not going to be eligible to renew through auto renewal. The rules that are in place for the number of renewals allowed are still respected. Once the established limit is reached, the renewal will not be allowed.

Can patrons just keep items forever?

No. There is a limit to the number of times an item can be renewed. In our system the maximum number has been set at 2. Once the item has been renewed 2 times (using any method to renew) it will no longer be eligible.

What if a patron has items from different libraries?

If the items are checked out at libraries who participate in automatic renewal, any item that can be renewed will be renewed and a new due date will be assigned. The notice will include all items that are due 3 days from the date the notice is sent.

Can a library choose not to participate?

It is possible to opt out of the Auto Renewal of items checked out of your location. It is not feasible to exclude your items from auto renewal, when checked out at other libraries. Additionally, your patrons who check out at other libraries will be eligible for auto renewal.



#### New Feature F.A.Q.

What do I need to do to participate?

We will be turning the feature on for libraries who do not opt out. MHLS will manage the sending of the notices. There is nothing for the participating libraries to do.

How will this affect my statistics?

Your renewals will go up. The renewal will be attributed to the checkout location each time the item renews. You will see an increase in this statistic. Renewals are counted in the Annual Report as checkouts. The checkouts report should not be affected. We will be tracking the increase in renewals.

My library counts on the money collected by fines. Will I lose all of that revenue?


No. Human nature extends to patrons. People will still have late fees even when items have been renewed for them. Data from a library who has used auto renewal cited only a 50% decrease in revenue while improving the patron experience.

What if a patron doesn't have email?

Their items will still be renewed, but there will be no way to let them know. This is a good opportunity to get patrons to provide an email. We can add a pop up to all of your patrons who currently do not have an email in their record.

What does a courtesy notice look like and is it customizable?

A sample courtesy notice has been provided here. This template can be customized by the DA, but the notice must serve the needs of all participating libraries. MHLS will be sending out the notices using a single notice template, and cannot be customized for each library.

## Fines free: Getting there in stages: a primer for county wide discussion

What is fines free: Fines free means that certain patrons or certain items will not be assessed an overdue fee. Replacement fees for items not returned are still assessed. Fines free isn't new, in fact there are 12 libraries in our system that are 100% fines fee. Libraries across the country are trending away from fines. Many MHLS libraries have expressed an interest in moving in that direction by embracing Partial Fines Free, where the library is limiting the fine freeness to a subset of patrons or items.

#### Why do we need to talk about this as a group?

To accommodate a partial fines free library we would need to expand either our item types (itypes) or patron types (ptypes) to allow us differentiate those free items or patrons separately in the loan rules, depending on how it is deployed. Our upgrade to Sierra 4.0 included an expansion to the capacity of both of these codes. which frees us up to more flexible in accommodating. MHLS needs to be able to make these expansions happen, but also to manage the process within the limits that serve the entire membership and the overall management of the ILS.

What are the options? Dipping a toe into freedom may be the way to move your library to fully free. You can choose to limit by Collection (itype) or by patron age or ptype. It is possible to apply both. You might wish to allow your children's collection to be free, but only to children under 10.

#### Great! So we can be completely free?

Well sort of... While we have expansion, there are still limits and the libraries are still sharing the loan rules, which have not expanded. The fewer variations on the rules, the easier it is for us to manage, sure, but also from the library staff's perspective and the patron's vantage point, less is almost always more. It is easier to enforce and comprehend a more stream lined approach within a library and across neighboring libraries.

**Action**: Discuss at the county level, defer to the Resource Sharing committee, who will recommend an Action item for vote at the DA. The action item can stipulate the limitations on expansion.

- Expand item types to accommodate fine free collections (which itypes or all)
- Expand ptypes to identify a fine free patron type for each library (remembering they will be free only where local libraries extend freedom).
- Begin using patron age in our loan rule- we currently have not included that element.

#### Fine Free Collections

In order to have segments of the collection be fine free, to anyone or segments of a population, the collections need to be separated into itypes. If you wished to make your Juvenile collection fine free, MHLS could identify your Juvenile collection using the Annual report code, and globally update those itypes to





By Birthdate: If there is an age segment or even multiple ages that you would wish to be fines free, we can set up a line in your libraries loan rules to manage that for each itype group. Using this, you could allow patrons under 5 to be fines free, over 65 to be fines free, or both. This method has the advantage of being a "set it and forget it" method that works across all patrons without additional entry, if their record includes a birthdate.



Fine free Ptypes for each location: Currently we have a single ptype for each library. These are numeric codes. We could append our current list with a group of ptypes that can be used for adding the privilege of being fines free (very much like the old 4-VIP), which is no longer in use, but for each library. We would end the list below with another 70 ptypes, one for each library. Libraries would need to edit, or identify a group of records in a review file for updating.
